- asked for the committee's opinion on the logo and engraving. She added that
- 47 they also engraved a beer bottle opener. The committee discussed changing
- the logo to increase the size of Sandown and to add the event date. The
- committee discussed different pricing options for the mugs, the opener and a
- 50 combo.
