Sandown Master Plan Survey Summary January 9, 2011

A BRIEF OVERVIEW:

In the Spring of 2011, UNH Cooperative Extension helped the Sandown Master Plan Committee to develop a Master Plan Survey aimed at garnering public input for the revision of the Town's Master Plan. The survey was developed as a web-based survey, with options for residents to take the survey in hard-copy form. The survey was piloted at Old Home Days and the web-link was later shared with town residents via a postcard and responses were collected through December of 2011. Hard copies were also made available at Town Hall. Survey following survey analysis was conducted by UNH Cooperative Extension.

I. Survey Demographics

- 129 people responded to the survey (106 full responses and 23 partial responses) for a household response rate of 5.7%.
- Of the 129 respondents 36 completed hard copies and 93 completed the survey on-line.
- 52% of respondents were female; 48% were male
