

Sandown Police Explorer Application Packet

General Membership Requirements

1. Applicants must be between the ages of 14 (and out of the eighth grade), and 21 years of age.

2. Parental approval must be obtained.

3. School transcripts demonstrating a 2.0 grade point average, or better, must be enclosed with the application.

4. The applicant must be in good health and without physical condition(s) that will endanger them, or another member of the Police Department.

5. The applicant must be of good character and possess good moral habits. Driving records will be considered.

6. All applicants who are accepted must attend four consecutive meetings, and within four weeks of that having been completed must possess a Sandown Police Explorer uniform.

7. Upon appointment to the Post, a mandatory six months probation period must be served.

8. All applicants must successfully pass a background investigation including, but not limited to, a criminal history records check.

9. None of the above requirements is intended to be an automatic disqualifier. All of the above are taken into consideration when considering an applicant. If you feel that there are special circumstances that should be considered when applying, contact the Explorer Coordinator.

When filling out the attached application:

• Fill in all of the blanks. If an item does not apply to you put in N/A.

• Give complete information, including your first, middle, and last names completely spelled out.

• Submit only information you are sure of.

• Be sure that you and/or your parents sign the forms in the appropriate places.

• INTENTIONAL WITHHOLDING OF INFORMATION OR FALSEIFICATION OF INFORMATION ON THIS APPLICATION WILL RESULT IN IMMEDIATE DENIAL OF ACCEPTANCE. If the applicant is accepted and falsification is discovered, the Explorer will be dismissed without recourse.
