PLEASE NOTE: No RFP will be reviewed for consideration unless accompanied by a current copy of certificate of insurance. If selected, Town of Sandown is to be named as an additional insured. A decision will be made by April 5, 2023 or before. If selected, pricing will remain in effect through December 31, 2026. Please price accordingly. Additional information may be requested including references.

Your participation in this process is encouraged and welcomed. Please note that playing fields are heavily utilized during the months of mid-April, weather depending, thru the end of June and again from September thru beginning of November. It is *imperative* you are available to mow, often with short notice, during playing seasons to facilitate the playing of youth baseball, softball, and soccer. You may need to adjust your schedule to ensure that grass is kept to an appropriate playing level, particularly after periods of rain. Contractors who will have the flexibility to make these accommodations are required. Some areas located outside of actual playing surfaces, are only done every other week and/or as needed – please see requirements.

RFPs should be priced per occurrence. You will be asked to submit documentation each time mowing takes place. Actual bills must be submitted with no greater than a monthly occurrence.

Insurance Certificates must be current and on file with the Parks and Recreation Department prior to any work commencing in 2023.
